MAHARASHTRA COUNCIL OF ACUPUNCTURE

Empanelment of Advocates

Maharashtra council of Acupuncture is a statutory body of the ministry of Medical Education & Drugs of Government of Maharashtra constituted for determination & coordination of standards of education & maintenance of register as per Maharashtra Acupuncture System of Therapy Act,2015. It proposes to make Panel of Counsels to represent the Maharashtra Council of Acupuncture before various High courts/Supreme court/ CAT/MAT etc. and for the assistance in various council proceedings, inquiries & legal drafting etc.

The Practicing advocate who are registered with Bar council of India/state Bar Council are eligible for empanelment. The qualification, experience, schedule of fees, other terms and conditions and the application format in which the application has to be submitted, have been prescribed. The duly signed complete application should be submitted only in the format prescribed in annexure "A" enclosed herewith. The practicing advocate must sent their application along with all supporting documents in sealed envelope to Registrar, Maharashtra Council of Acupuncture, DMER Office, 4th floor, St. George's Hospital Campus, Govt. Dental College Building, fort, Mumbai-400 001 in a sealed envelope by mentioning "Application for empanelment of advocate". Application sent by email or unsigned application shall not be entertained". Last date for application is 25/01/2022.

Application for empanelment at Maharashtra Council of Acupuncture does not confer any right/ assurance whatsoever, to an applicant that he/ she will be empaneled on the panel of Maharashtra Council of Acupuncture. Letters to advocates confirming their empanelment will be issued by Maharashtra Council of Acupuncture separately. The Advocates who are handling court cases of health professional Councils / Universities/ Academic institutions/ UGC/ State Government/ Central Government /PSU/ Government Autonomous bodies will get preference.

GUIDELINE FOR EMPANELMENT

Following guideline are designed to provide and regulate the manner and procedure for empaneling advocates to represent and assist MS Maharashtra Council of Acupuncture before various courts and for regulating referrals of the cases and payment of fee/ remuneration. These guidelines shall supersede all existing instructions in this regard, if any and is subject to change without assigning any reason.

1. Eligibility of empanelment

- a) The applicant has valid registration with Bar Council of India /State Bar Council.
- b) The applicant must have 10 years standing experience in court/s OR
- c) High Court Lawyer

2. Tenure of empanelment

The initial in empanelment will be for period of 05 years. Performance of empanelment advocates shall be reviewed at regular interval for continuance of their name in panel.

3. payment of fee and other conditions

The fee shall be such as may be decided by the State government State government/ Council from time to time on case to case basis . No advance fees hall be paid. It will be responsibility of the Advocate (to whom any case is assigned) to submit the certified copy of the judgement so that full and final payment is made.

4. Removal for the panel

Empanelment shall be liable to be cancelled due tooccurring of any of the following

- a) Giving false information in the application for empanelment
- b) Failing to attend the hearing of the case without any sufficient reason and /or prior information.
- c) Not action as per MS Maharashtra Councilof Acupuncture instructions or going against specific instruction.
- d) Passing on information relating to MSMaharashtra Council of Acupuncture case on to the opposite parties or their advocates or any third party which is likely to cause damage to MSMaharashtra Council of Acupuncture interest.
- e) Threatening, intimidating or abusing any of the MSMaharashtra Council of Acupuncture employees officers or representative.
- f) Giving fails or misleading information to the MS Maharashtra Council of Acupuncture relating to the proceeding of the case.
- g) Seeking frequent adjournments or not objecting the adjournments moved by other party without sufficient sent reason.
- h) Frequent absence from the court proceedings even if 'pass over' or 'proxy' is obtained by an advocate.
